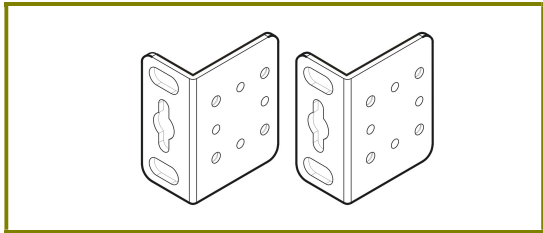

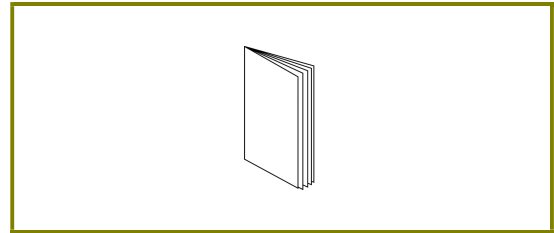
VigorSwitch PQ1070x (with PoE)



VigorSwitch Q1070x (without PoE)

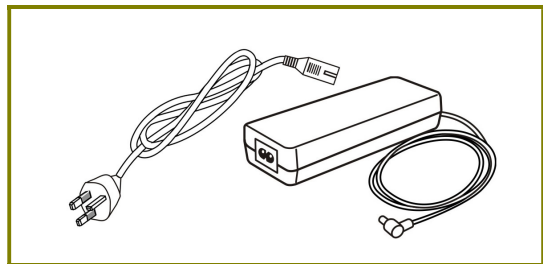

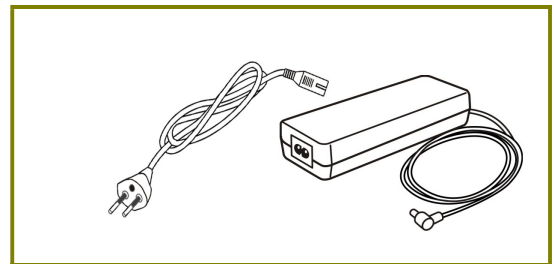

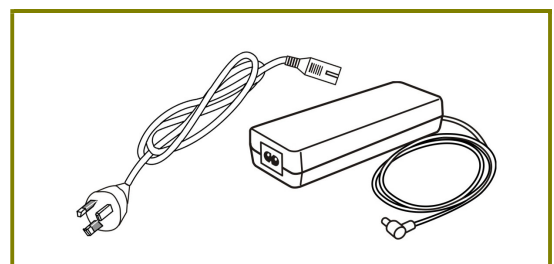
UK-type Power Adapter



EU-type Power Adapter

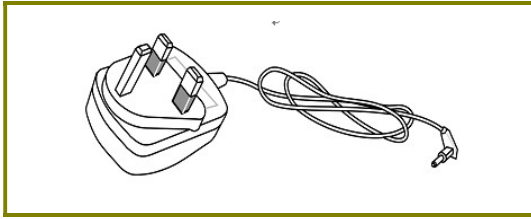

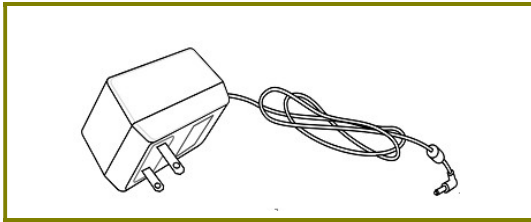

2. Panel Explanation



LED	Status	Explanation
PoE/Alert (for PQ1070x)	Blinking (Green)	The power is over (>) 80% watts PoE power budget.
	Off	The power is under (<) 80% watts PoE power budget.
PWR/SYS	On (Green)	The switch finishes system booting and the system is ready.
	Blinking (Green)	The switch is powered on and starts system booting.
	Off	The power is off or the system is not ready / malfunctioning.
Port 1 ~ 5 (PoE, for PQ1070x)	On (Green)	The port is supplied with PoE power.
	Off	No PoE power is supplied on the port.
Port 1 ~ 5 (GbE RJ45)	On (Green)	The device is connected with 2.5Gbps.
	On (Amber)	The device is connected with 1G/100M/10Mbps.
	Blinking	The system is sending or receiving data through the port.
	Off	The port is disconnected or the link is failed.
Port 6 ~ 7 (SFP+)	On (Amber)	The device is connected with 2.5/1Gbps.
	On (Blue)	The device is connected with 10Gbps.
	Blinking	The system is sending or receiving data through the port.

RST	Factory reset button. Press it to reboot the system. (<5 seconds) Press it to reset the system with factory default settings. (>5 seconds)
Port 1 ~ 5 (2.5GbE RJ45)	Port 1 to Port 5 can be used for Ethernet connection and PoE connection, depending on the device connected.
Port 1 ~ 5 (PoE 802.3af/at/bt, for PQI070x)	
Port 6 ~ 7 (SFP+)	Port 6 to Port 7 are used for fiber connection.

3. Hardware Installation

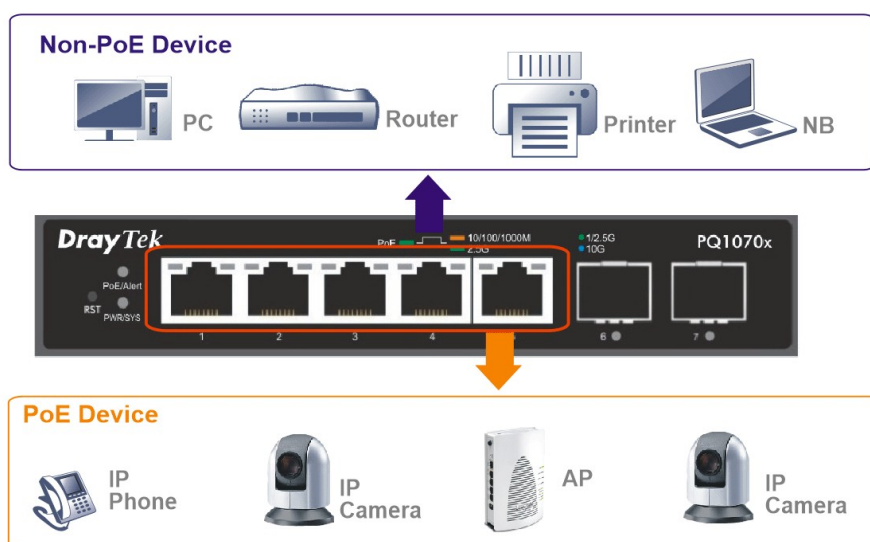
Before starting to configure the switch, you have to connect your devices correctly.

3.1 Network Connection

Support Non-PoE devices and PoE devices

- Use a Cat. 5e twisted-pair cable to connect a PoE device to the port (1-5) of this switch.
- The switch will supply power to PoE Device over the twisted-pair cable.
- Please note that Power Device must comply with IEEE 802.3af/at/bt.
- Other PCs, servers and network devices can be connected to the switch using a standard 'straight through' twisted pair cable.

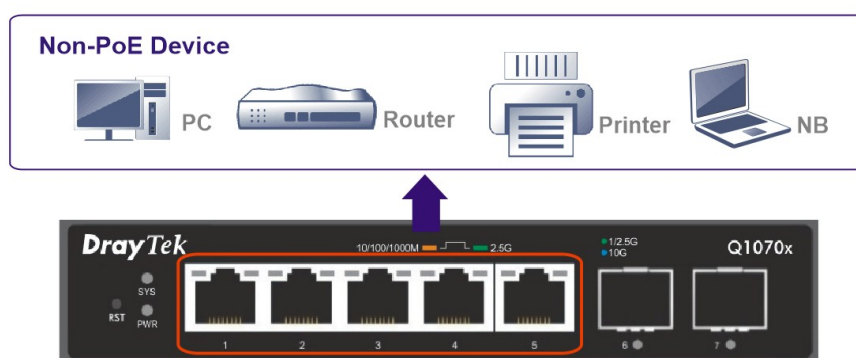

- Use the Ethernet cable(s) to connect None-PoE devices to the Vigor switch.
- All device ports are in the same local area network.

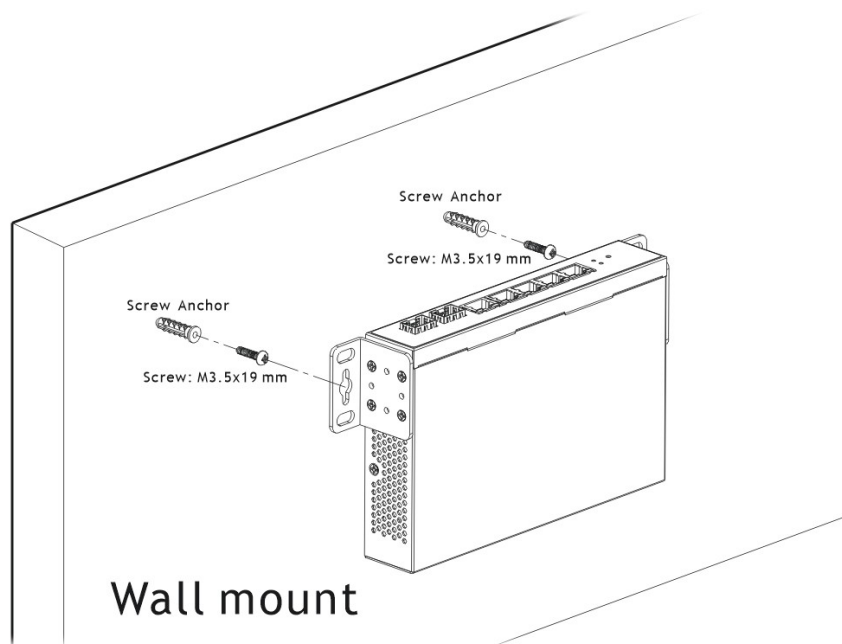
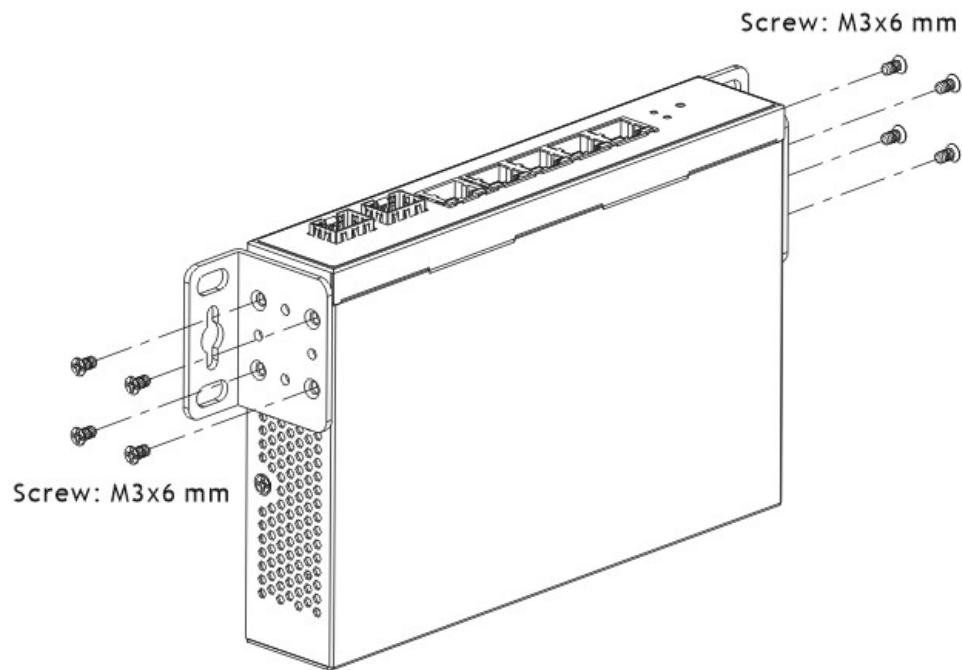

3.2 Wall-Mounted Installation

The switch can be installed easily by using **wall mount kit**.

1. Attach both brackets to Vigor Switch with the fastening screws.
2. Refer to the following picture to find the recommended pairs of screw anchors and screws. Insert two anchors into the wall.
3. Lock the screws on the anchors.
4. Hang the access point on the anchors

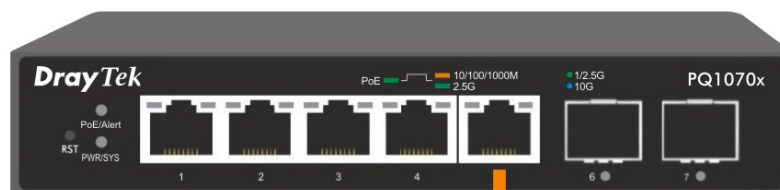

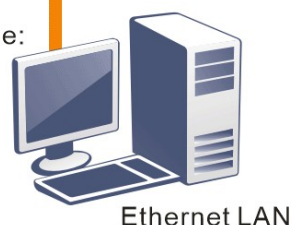

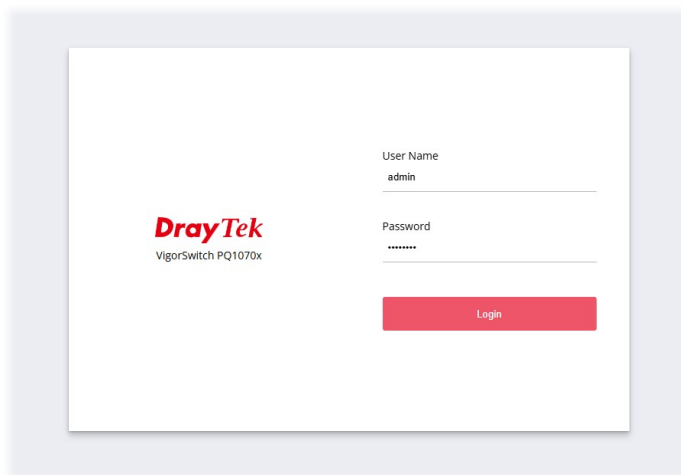


Before using the switch, perform the following steps:

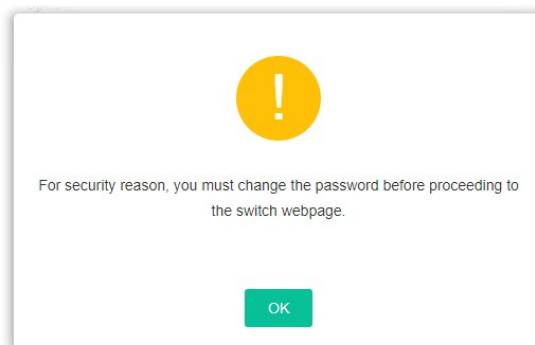
1. Set up a physical path between the configured the switch and a PC by a qualified UTP Cat. 5e cable with RJ-45 connector.
2. If a PC directly connects to the switch, you have to setup the same subnet mask for PC and the switch. Default values of the managed switch are listed as follows:

IP Address	192.168.1.224
Subnet Mask	255.255.255.0
DHCP Client	Enabled (On)
Username	admin
Password	admin

3. After configuring correct IP address on your PC, open your web browser and access switch's IP address.
4. Please enter "admin/admin" as the Username/Password and click **Login**.



5. Next, a page will appear to guide you change the login password. You **MUST** change the login password before accessing the web user interface. Please click **OK**.



6. Please set a new password with the highest level of strength for network security.

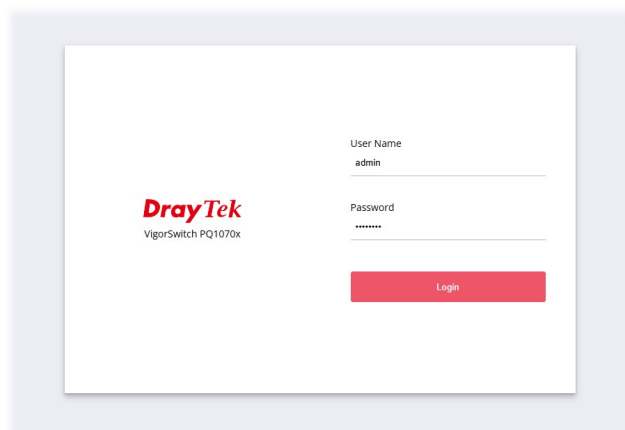

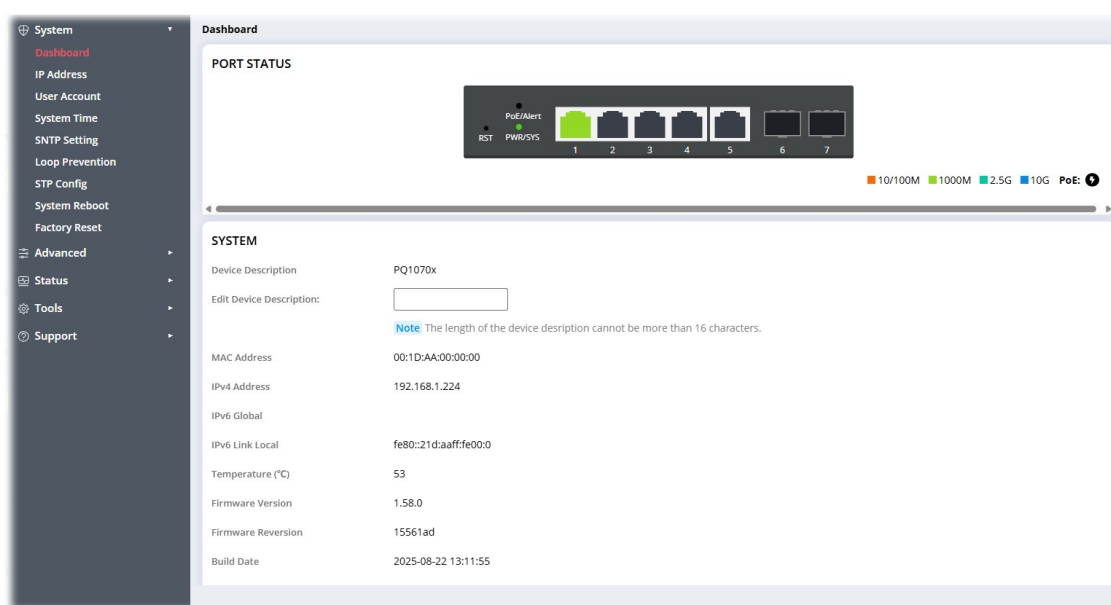
